PROPOSED CITY ORDINANCE TO AFFECT SOUTHGLENN

We have a very important report from Andrew Spaulding in this newsletter which I urge you to read about an ordinance currently being proposed concerning Accessory Dwelling Units (ADU's). If Ordinance No. 2024-O-03 passes it will have a huge impact on our wonderful single-family home and residential housing in SouthGlenn, and it will destroy our wonderful high home values! WE NEED YOUR HELP – we have a chance to defeat this ordinance if we show up to the May 7th City Council Meeting at 7pm in numbers!

We must call our city council representatives weekly and tell them that ordinance is not wanted and attend council meetings as a neighborhood-they do listen! If we complain to our City Council members it can make a difference. We want to keep our community as the single-family residential homes we bought into!

The second reading of the ordinance will be May 7th at 7:00pm at the City Council Meeting and public hearing in the City Council Chambers, at the Centennial Civic Center, 13133 East Arapahoe Road Centennial, CO 80112. WE NEED YOU THERE!





CITY HALL HAPPENINGS — A MUST READ! WHAT THE CITY OF CENTNNIAL IS TRYING TO LET HAPPEN

KILLING ADU'S, By: Andrew Spaulding

A few years ago, I was invited to sit on the Centennial's Affordable Housing Commission to study ways to try and create more affordable housing. The Commission came up with 10 possible options which were whittled down to three that were recommended for consideration by the City Council. The three are Accessory Dwelling Units (ADU's), Land Banking and Inclusionary Housing.

On March 5th after a years' worth of work by City Staff, the first reading of an ADU ordinance was presented. For those of you that don't know, the first reading for an ordinance is the final draft to be tweaked with it normally being approved on the second reading. I reviewed the ordinance and after less than an hour realized it was totally flawed. The main issues I discovered are as follows:

- 1. The definition of the word "Accessory". To me an accessory is a necklace, watch, air conditioning in a car, something extra--not the whole thing. The housing commission envisioned small little homes on the existing property. This ordinance would have allowed someone to build homes larger than the smallest home originally built in SouthGlenn.
- **2. Size issues.** It would vary depending on the footprint of living space of the main house. 50% of the ground level living space would be allowed. It also allowed for 17 feet

height or two-stories. This would result in space equal to the footprint of the main home. SouthGlenn homes are built on ½ to ½ acre lots. Homes range in size from 1,200 sq/ft to over 3,000 sq/ft. Is it really an ADU if it's equal to or larger than some of the smaller homes in SouthGlenn? This was not envisioned by the housing commission. Nor would it result in affordable housing.

- **3. No land to building ratio was included.** Current ordinance allows a detached garage up to 850 sq/ft.
- 4. If someone chose to do that and an ADU the backyard would be filled up. I didn't believe that was something SouthGlenn homeowners would want.

My intent speaking at the meeting was only to get my thoughts on record so I could later say, "I told you so", since once something gets to the first reading nothing stops it. I said what I had to say and left; I didn't stay for the balance of the meeting. The next morning my phone and email blew up from people that did stay for the whole meeting indicating the City Council killed the ordinance. Mostly from what I told them! You could have knocked me over with a feather.

My hope is that this story will motivate you to get involved and make your voice heard. If you show up with facts, logic, and reason they will listen, and you can make a difference for our community.
