Help Support Lucy Harris After Life-Altering Injuries

Organized by Kelly Borgia, from the gofundme page:

"Hello, my name is Kelly and I've created this fundraiser on behalf of my sister, Jennifer, and her family. We wouldn't be asking for help if it wasn't absolutely necessary. I'd like to start by thanking everyone who has already contributed to this fundraiser by donating and/or sharing. Your kindness and generosity mean the world to our family during this difficult time. Each time I raise our "goal" amount, I am amazed and overwhelmed at the response received. While the amount raised is beyond any expectations I had starting off, my sister and her family will still



need more to help them navigate through this tragedy. Please consider donating and/or sharing as every little bit helps.

WHY WE NEED YOUR HELP:

On July 15, 2023, Jennifer and her two children were involved in a serious car accident, in which at a complete stop, they were rear ended by someone going 60 mph. The accident resulted in injuries for both Jennifer and her 10-year-old daughter, Lucy. Fortunately, her son, Calvin, was left unharmed. Jennifer sustained a concussion, as well as a broken wrist, and various cuts and bruises. Lucy's injuries are devastating, and life altering. She endured a splenectomy, bleeding in her lungs, a few broken bones and a brain

bleed, along with a few other minor internal injuries. While she is recovering well from those injuries and is currently stable, she will never recover from her most severe injury: a severed spinal cord, that has left her paralyzed. Doctors say our sweet, strong, vibrant, kind-hearted, active Lucy will never walk again. Her life will never be the same. A child who loves nothing more than to be on the move - playing soccer, swimming, biking, hiking, climbing and running around with her friends. All things she will have to learn how to do a bit differently, if at all.

As this was an unexpected tragedy, our family needs your help to make this difficult transition into a new way of life as smooth as possible. Please help if you can. In addition to keeping up with everyday expenses (mortgage, utilities, groceries, etc.), medical expenses are quickly accumulating. Peter and Jennifer will need to take an extended amount of time off of work, make significant modifications to their home, purchase a new vehicle capable of transporting their daughter, purchase necessary medical equipment to accommodate her daily needs, and provide around the clock care for her. She will require rehabilitation services and therapies, as well as lifelong medical support and care.

If you know Jen and Peter personally, please hold off on reaching out to them directly at this time, as they are still trying to heal and focus on Lucy.

Your donation is extremely appreciated and we will be forever grateful of your help during this challenging time. Thank you for your time and support. – Kelly and the Harris Family"

2nd Annual Tsunami Tsoiree


Knolls neighbors and swim team families, you are invited to The Second Annual Tsunami Tsoiree!

News From The Knolls Courts

As our summer heats up, it is lovely to see our pickleball and tennis communities active on our beautiful courts. Leagues are in full force, and kids' lessons are helping grow our community.

Scheduled repairs have been completed to re-coat chipped surface areas on courts 1, 2 and 3 and do minor crack repair on 3 and 4-North (closest to pool). The 4-South court has a more serious repair that should be completed soon – stay tuned. We are beginning to source bids for a post-tension full replacement of courts 3/4 for as soon as possible, hopefully Fall 2024. New keys will be exchanged on/around the Labor Day tournament for residents – the HOA will provide multi-use keys that open the lower south clubhouse door for bathrooms and court gates.

We hosted a free Friday social with the mid-summer Tennis/ Pickleball tournament July 21-22. The next social dates are Friday, August 4 (including fun drills with a pro) and August 25 (play and social only) from 6-7:30 p.m. Socials are fun, casual matches mixing up all player levels - *adults only* - followed by a social BYOB and snacks to share. August Gardening Calendar

As gardeners, we enter a slower, more easy-going phase in the garden process. There's always something to do in the garden but we don't need to keep up the frenetic pace of plant-



ing-mulching-weeding that April and May demand. June's blooms may have faded, but with proper pruning some may make a reappearance in August. July's heat is over and there's still a lot of summer left.

In August harvesting our gardening efforts has begun, but we can take time to do it right, even enjoy the process. If we pay attention, August presents a wisdom not available any other time of year. The garden is maturing now. We can see our mistakes, our successes, and the intrusions on our efforts that nature presents on her own. In August there's time to look around and appreciate the garden...and then get back to work. **MAJOR CHORES FOR AUGUST:**

<u>Lawn:</u>

- Begin lawn renovation and repair. Build up low areas with garden soil and over-seed areas that are thin or bare.
- Attack persistent weeds like bindweed with a 2, 4-D product. But the ultimate goal is to grow a thick healthy turf that will choke out weeds.

Vegetables:

- Plant spinach and lettuce mid-month for a fall harvest.
- Harvest cucumbers intended for slicing when they are 6 to 8 inches.
- Onions are ready to harvest when their green tops fall over. Lift the bulbs and brush off loose soil. Bring them to a protected area like a porch or covered shed. Lay them out in a single layer on a surface that permits ventilation top and bottom. When the outer skins have turned papery place them in a mesh bag or old panty hose and place them in a dark and cool place.
- Peppers can be harvested anytime they achieve the size you need or want.
- Water tomatoes regularly until late August. After that, fruit will ripen more quickly when water is withheld.
- After harvesting and areas become empty sow cover crops, like annual rye grass, often called green manure, to build garden soil.

<u>Garden:</u>

- Newly planted perennials, trees and shrubs need consistent watering to get established.
- Fertilize roses for the last time around August 15th. Fertilizing later may stimulate new succulent growth that could damage the plant if there is an early frost.
- Divide spring blooming perennials if needed. Ways to tell if a perennial needs to be divided is if the plant has a 'hole' in the middle and doesn't look as attractive as it used to, if blooms decrease or stop altogether or if the plant is crowding out neighboring plants.

Take advantage of plant sales. Usually starting mid-to-late-August and into September many nurseries will have plants sales with prices as much as 50% off.
