We reviewed our 2024 budget and reserve study, and with lots of eyes were able to do some fine-tuning for the coming year. We'll be emailing out the final version to the entire neighborhood soon, so be on the lookout. At the annual meeting we also counted your votes for our 2024-2025 HOA Board members. There were 98 homeowners who cast ballots, and the top four vote-getters were (in alphabetical order) Travis Baumgart, Molly Ehlinger, Justin Finesilver and Diane Klepacka. I am very excited about this group and their energy and interest in the wellbeing of the neighborhood. I'm keeping this short to make room for a word from one of our city council members but hope to see many of you at our holiday party on Dec. 2nd!

A Message From The **Centennial City Council:**

Hi, neighbors – As I write this, the asphalt on the bridge on Arapahoe Road is being laid and the lines should be put down this week. We are finally seeing the finish line on what was the largest public works project undertaken by the City of Centennial. There are additional details that will need to be finished over the following weeks, but as you are reading this the majority of the work is complete. Many thanks to Conrad Steller and Dusty Laird for working with the city to ensure the monument replacements were similar or better than what was there before.

The bridge will include the first mural for our city. This will be as you walk/bike/stroll under the bridge and will be on the far side of the creek. The Centennial Arts & Cultural Foundation will ask for input in the selection process, so watch for information if you are interested in being one of the art work judges.

The City of Centennial has approved our 2024 budget, and it includes several public works projects that were described in the newsletter every household received in October. The budget also has an increase of a \$1M to the Arapahoe County Sheriff's Department. This will include four additional deputies and one investigator, and we continue to fund our co-responders, and school resource officers and therapy dogs.

In 2024, you will see some major projects from our city partners. This includes Denver Water replacing water lines in a section of our neighborhood. They have planned this to meet the city schedule of mill and overlay work.

South Suburban Parks and Recreation plans include replacing the playground at Cherry Knolls Park. The play equipment is more than 20 years old. I was recently at ribbon cuttings for both the Linksview Park and Cherry Park and am excited to have a similar playground at Cherry Knolls.

Littleton Public Schools will be planning a ribbon cutting for the new Centennial Stadium in the spring. It has held a couple of events, but with the weather changing, they wanted to wait until it was a bit warmer.

I hope everyone has a wonderful 2024! I truly appreciate your support in allowing me to continue to serve as your City Council Member.

New Clubhouse Reservation and Access System

The board has implemented a digital lock box system, aimed at enhancing convenience and security for all residents.

A few of the benefits to using this digital lock box system are: **Convenient Access:** The new digital lock box system provides an easy and convenient way for homeowners to access the clubhouse, offering greater flexibility in usage.

Enhanced Security: The digital lock box is designed with security features to maintain the safety and protection of the club-house. The reservation manager will be able to access the code log used to open the box

The new reservation system will be:

- 1) Email the clubhouse reservation manager at ClubhouseCalendar@theknollshoa.com.
- 2) The clubhouse reservation manager will reply with an email informing homeowners of next steps for reservations. Part of the reservations will be filling out an ACH form that will be kept on file for each homeowner. In the reservation email the homeowner will receive an ACH form to fill out. They may either send back electronically or drop off as a hard copy.
- 3) Once the ACH form is received the homeowner will be given an access code for the lock box and further instructions on how to check in and out for the reservation.
- 4) Homeowners will be required to fill out a cleaning checklist prior to exiting the clubhouse. This check list will be available digitally to submit or hard copies are provided in the clubhouse binder

PLEASE REMEMBER:

With snow and moisture on the way, please do not use shovels on the courts. There are squeegees and rollers to help without harming the surface. Pulling back the divider nets between courts can also help prevent snow from piling up.

Remember to lock the courts after you play. The ball machine may only be used by players over the age of 16 or with a parent onsite for younger children. Also, please empty the court trash bins if needed.

Please refrain from depositing dog poop bags in the trash cans adjacent to the courts as people congregate there before and after play.

These responsibilities will be transitioned into the new role taken up by Ryan Page.

These changes mean that for the last few months a committee of four has been serving the 399 homes in the neighborhood. We would love to see a few more community members step in to serve their neighbors. If you are willing, please reach out to the Board. If you have questions about what this looks like, any current member would be happy to chat with you.

Curious about what the ACC does? One part of our role is to walk homeowners through the process of making changes to the exterior of their homes. I think most committee members would say helping with these positive changes is their favorite part of the commitment. Another big part of what we do is to review applications for changes at our monthly meeting as well as via email. This year we reviewed 104 applications. We also walk our zones in an annual audit to keep an eye on repairs a homeowner may not have noticed. As homeowners, we do not spend as much time looking at the exterior of our homes as our neighbors might. Recently, the ACC has taken on the role of the Welcome Committee, and we visit new homeowners to



deliver the directory and see if they have any questions about the neighborhood. I know I have really enjoyed this. In the past

the neighborhood. I know I have really enjoyed this. In the past year, we have worked to update some guidelines to bring clarity to our process. We have also reviewed a new siding option and selected colors from their offerings. The more members we have, the more time there is to take on special projects such as these. If this sounds like something you would be interested in helping with, we would love to have you.

One more update, we will not be having our regularly scheduled meeting on January 2, 2024, and will handle urgent requests in a timely manner.

Homemade Candy Canes


These homemade candy canes are SO much better than store-bought, and so fun to make! Just make sure you have a stick of butter handy to keep your hands buttered for pulling so it doesn't stick to you.

Ingredients:

- 2 cups sugar
- 1/2 cup light corn syrup
- 1/2 cup water
- 1/4 tsp. cream of tartar
- 1 tsp. peppermint extract
- 1 tsp. red food coloring

How To Make:

- 1. In heavy-bottomed large saucepan or small pot, combine first 4 ingredients and stir
 - until sugar dissolves. Cook, without stirring to hard-ball stage. (265 degrees.)
- 2. Remove from heat and add peppermint extract. Divide into 2 portions, and add coloring to one part. Pour out onto buttered cookie sheets. (Pour half onto one sheet, then add coloring to the rest and then pour onto second sheet.) when it's cool enough to handle, start pulling each part separately. (Best done with 2 people, but if doing alone, go back and forth pulling each.)
- 3. When you feel like you just can't pull anymore, form into ropes and twist them together. Cut into 8" lengths, form into the shape of candy canes, and place on lightly buttered platter til fully hardened.

Outdoor Ice Skating Rinks

You don't have to hit the slopes to have some cold, wintery fun. Check out these rinks to get your ice skating fix.

RINK AT BELMAR, LAKEWOOD

Admission (skate rental included): \$10 (\$8 for kids 12 and under; seniors and children two and under skate free) or \$6 if you bring your own skates. Park in the lot at Teller Street and West Virginia Avenue. Even in the daytime, the Rink at Belmar can get plenty of shade, so make sure you check the weather and bundle up. Extreme weather may close the rink, so check online or call ahead to make sure the rink is open as planned. Outdoor heaters and fire pits help friends or parents stay toasty.

SKATING IN THE SQUARE, ARVADA

Admission (skate rental included): \$10 (\$7 for kids 12 and under). Take the G Line to Olde Town Arvada, and you'll find a cozy little skating rink in the square on 57th Avenue, between the library and the pedestrian mall. Pick up your skates at the nearby shed and take to the (synthetic) ice.

PARKER ICE TRAIL, PARKER

Admission: \$9 (\$7 for kids 10 and under). Skate rental: \$4. The ice circles a center grassy area and is fenced in on both the inside and outside, offering more space for beginners to hold on as they get accustomed to the ice. Located at the edge of downtown Parker in Discovery Park (behind the library), the ice trail offers concessions, skating aids for new skaters, and a handful of fire pits and seating for spectators to keep warm.

DOWNTOWN DENVER RINK, DENVER

Admission: Free. Skate rental: \$11 (\$9 for kids 12 and under; fourth graders skate free). The downtown rink sits in Skyline Park, in the shadow of the Daniels & Fisher clocktower between the 16th Street Mall and 17th on Arapahoe Street. Open late on holidays and weekends, the rink offers concessions and locker storage for your belongings. Fourth graders skate free, and double-bladed skates are available in children sizes.

EVERGREEN LAKE, EVERGREEN

Admission: \$14 (children four and under skate free); \$20 with skate rental included. Skate rental: \$10. Winning the prize for best views while skating, Evergreen Lake is open throughout the winter as weather permits. Learn to Skate classes are available for children, and athletes can sign up for hock-

ey and broomball online. Regulars or families can purchase 10-punch skate cards for \$120 (\$30 savings). Park at Evergreen Lake House or take the shuttle from Stagecoach Park lower parking lot on weekends and holidays.

Christmas Tree Cutting

Cutting down your own Christmas tree can be a memorable and festive experience for the whole family, but it's key to do this activity safely and legally. In Colorado, you typically need a permit to cut down a Christmas tree on public lands. Here are some spots where you can obtain a permit and some tips for doing this activity responsibly. All permits can be purchased online at recreation.gov.

- 1. Plan Ahead: Contact the forest service or visit their website for more information on permit availability, cutting dates, regulations, and designated cutting areas.
- 2. Choose the Right Tools: Bring a sharp saw for cutting and ropes or straps to secure the tree to your vehicle.
- 3. Select a Healthy Tree: A healthy tree will have vibrant green needles (avoid trees with brown or dry needles).
- 4. Dispose of the Tree Properly: Find a recycling program, chip the tree for mulch, or compost it.
