Displaying the Stars and Stripes

It gives me a great deal of pride when I drive or walk through our neighborhood and see the Stars and Stripes being displayed in front of so many homes. As a veteran I'm extremely proud of my Tiffany neighbors for their visible display of Patriotism and Pride in America!

Now, having said that, I would like to make my neighbors aware of the US Flag Code. The code establishes advisory rules for the display and care of the National Flag of the United States of America. You can get a copy of the Code at WWW.Legion.org and search for US Flag Code. There are a couple of sections of the Code I would like to emphasize. First, the flag should not be flown/displayed on days when the weather is inclement, rain, snow, hail, etc., except when an

all-weather flag is flown! An all-weather flag is made of heavier material which will withstand the rigors of the weather. Second, the flag should only be flown from sunrise to sunset. However, when a patriotic effect is desired, the flag may be displayed 24 hours a day if properly illuminated during the hours of sunset to sunrise. The illumination must be specifically for the illumination of the flag and not the light peripherally available from street or yard lights.

I hope my neighbors will continue to fly/display the Flag while heeding these advisory guidelines! Thank you for your Patriotism and Pride in America!

The City of Centennial is wanting to make changes to Colorado Boulevard between Dry Creek and Arapahoe Road. The purpose of the changes is to slow down traffic. These ideas include changing from 5 lines to 3 lanes, creating wider sidewalks, and adding landscaped areas to separate pedestrians from the street. Fireworks

The following regulations apply only when a fire ban is **not** in place. (As of June 22, a fire ban was **not** in place according to the Arapahoe Sheriff's website so the following information is valid. Please check closer to the 4th for updated fire ban information.)

Centennial residents may use and possess certain "permissible fireworks," limited only to those that do not explode, leave the ground or fly through the air. Sparklers, cones, snakes and fountains are allowed. The decision to allow the use of certain types of fireworks is consistent with the State of Colorado and Arapahoe County. The sale of all forms of fireworks in Centennial continues to be prohibited. The use and possession of all forms of fireworks are prohibited in parks and open spaces in the City.


Summer Beats Concert

Berry Trifle: 8 to 10 servings; Total Time: 30 mins INGREDIENTS

- 1 angel food cake, cut into cubes
- 3.4 oz box instant vanilla pudding mix
- 2 cups cold milk
- 8 ounces cream cheese, at room temp
- 1 cup powdered sugar
- 8 ounces Cool Whip
- 2 pints blueberries, rinsed
- 2 pints strawberries, rinsed, hulled and sliced

INSTRUCTIONS

In a small bowl, combine the vanilla pudding mix with the milk and whisk for two minutes; set aside.

In a large bowl, beat the cream cheese on medium speed until smooth and creamy, 2 to 3 minutes. Reduce the speed to low and gradually add the powdered sugar. Once all of the sugar is incorporated, increase the speed to medium and beat for 1 minute, or until thoroughly combined and smooth.

Add the prepared pudding to the cream cheese mixture and gently fold and stir with a rubber spatula until completely combined. Add the Cool Whip to the bowl and fold it into the mixture until no white streaks remain.

To assemble the trifle, alternate layers of angel food cake, blueberries, the pudding mixture, strawberries and so on, until you get the top. Add a final layer of the pudding mixture, then arrange the remaining strawberries and blueberries in a decorative pattern. Serve immediately or cover and refrigerate until ready to serve. This is best served within 24 hours of making it, but leftovers can be stored in the refrigerator for up to 3 days.

Weeds Near Sidewalks

In a recent Tiffany newsletter, there was an ACC article that stressed the importance of removing needs that grow along the concrete next to the street. During a recent trip to Home Depot (in the gardening area), I saw 30% vinegar which may be very helpful for this purpose. Mix vinegar and a little salt and dish soap then spray on. Caution: This mixture may be harmful to the soil and plants you want to keep so use only where you do not want anything to grow. And wear long pants and gloves to protect your skin. — Debbie Rasor


