# Fly On The Wall

A standing room only crowd representing 123 of SP2's 548 homes gathered in the clubhouse for the SP2 HOA Budget Ratification and Annual Meeting Nov. 14. Here are notes and quotes from the evening:

- The budget was approved without a vote because the two-thirds majority needed to reject it was not present. More than twice the quorum of 55 was present for the Annual Meeting, which was called to order at 7:26.
- Treasurer Lorraine List introduced the 2024 budget with the fervent wish for good weather. "Snow can upset this budget like nothing else," she said. Board President Margot Langstaff piped up, "One good snowstorm and we're cooked."
  - In her "State of the Union," Langstaff said the 2023 goal of the board had been to get SP2 into shipshape, generating new documents, securing a new attorney and hiring a new property management company after considerable due diligence. "I'm very proud of what we've done. It's taken a tremendous amount of work."
    - Under the approved budget, monthly dues increase just \$8.86 per household, raising concerns about tree trimming,

# **Vote Yes To Avoid Special Assessments**

By now, owners of all 548 homes should have received both the proposed amended and restated declaration, and the amended and restated articles of incorporation, via U.S. mail. The Board of Directors has been working closely with legal counsel to provide the community with documents that will allow it to flourish now, and into the future.

Ballots must be returned by Saturday, January 13, and the threshold to make these changes is high:

- 67% of all owners (365) must approve the amended declaration;
- 75% of owners (411) must approve the amended articles.

If you have already voted, thank you. If not, submit your ballot now to save the Association time and money getting out the vote.

#### If you do not vote at all, you are voting no.

Vote YES to avoid the risk of special assessments, ensure that your board can properly maintain the community, protect your investments, and decrease future legal fees.

clubhouse painting, the lighting project and the sprinkler system. "I don't think that increase is enough, but it's up to you guys to change that," List said, urging owners to vote yes to update the SP2 governing documents.

- Owners voted to fill three openings on the board. The top two vote-getters will fill the three-year terms: Kolette Nelson (current board member serving as vice president) and former member Wiley Smith. The third-place finisher, board newcomer Andy Spiegel, will serve a one-term term to fill a vacated position.
- Spiegel, who has a strong financial background and volunteers as an accountant for the Small Business Administration, was so surprised to win a seat, he left the meeting before the selection of officers. They are: President Kenneth Ayars, Vice President Nelson, Treasurer List, Secretary Spiegel and at-large members Langstaff, Smith and Gary Hubbard.

anticipate storms about how they will handle them, which is information that I will generally forward to the board as well."
