

From The Inbox -

Concerned neighbor writes to CWCAtalk.com: "I see a neighbor behind me still has chickens and now I am dealing with rats in my yard and having to spend money on pest control. It's posted every month in the community newsletter, no chickens in this development. What can be done to shut this down? Can the neighbor be responsible to pay my pest control bill to trap and kill the rats? I have lived here since 1998 and this is the 1st time I'm dealing with rats. The mouse issue periodically comes and goes, but rats I was told are attracted to chickens coups, then bird seed."

The CWCA answers: Thank you for connecting with CWCA. I have forwarded your message to the Covenant Control Group for their review. The association continues to work hard to make sure neighbors are advised about the Covenant of no chickens allowed. Yet, some neighbors decide to disregard at the expense of other neighbors being negatively impacted. Please know that the association volunteers will help with the remediation of the situation by contacting the homeowners with a Friendly Letter explaining the Covenants.

Concerned neighbor writes to CWCAtalk.com on March 31: "Our neighbors had a dead tree fall from high winds. The tree fell along the fence line and broke down the fence between our two properties. While they have had the tree removed they have done nothing to fix the fence (they did say on April 2nd that they were planning to fix the fence). This has become a serious problem as I will soon explain. Last night we let our dog outside before bed and 20 minutes later we heard her crying and was being attacked by the neighbors dog on our porch

(this was the second incident we have had dealing with the neighbors dog)! We would appreciate some help and support from the HOA in resolving these problems with our neighbors."

The CWCA answers: Thank you for connecting with CWCA. I have reached out to the CWCA Board for their opinion and/or ideas about your current situation. First and foremost you have every right to secure your yard so as to keep yourself and your pets safe from harm. Having had the fence broken down by the neighbors tree is very unfortunate and them not addressing the issue in a timely manner is frustrating. It sounds like you have spoken with them and were given a small verbal agreement that they would fix the fence. Our community Covenants do not have any governance over this particular issue, so the association couldn't really hold them accountable. With that, you could do what you need to do to put up a temporary barrier to keep dogs in their own backyards. Another avenue is to connect with Jefferson County Animal Control, update them on the situation and your dogs recent event and see if they could do a home check and advise the neighbors to remedy the fencing. (In the interim a couple CWCA volunteers were able to upright the fencing panels, install temporary supports and add chicken wire for added security.) The CWCAtalk.com box receives many emails and tries to answer them in a timely manner. With an all volunteer staff and sometimes a message needing comments from multiple committees, it can take a bit of time to gather information and report back to questions. Thank you for reaching out.





Update From FHPRD On The Pool

July 12, 2023

Dear Columbine West Community,

Despite our intention and best efforts to open the Columbine West Outdoor Pool in 2023, we unfortunately will not be able to open this summer. The unanticipated construction delays are predominately due to the significant and extreme weather conditions we have experienced since the project began, including abnormal colder temperatures and snowfall, and unbelievably frequent, heavy rainstorms. These weather delays were paired with permitting issues early in the project and the discovery of a major storm sewer that had to be repaired and relocated by Jefferson County. All of these factors have greatly impacted the construction timeline.

We know this is disappointing to the Columbine West community, but we are excited to unveil new amenities to the facility when we reopen for the 2024 summer season and are confident that the community will enjoy the improvements for decades into the future.
