Columbine West has always had the ability to attract great neighbors looking for extra large lot sizes to help them store their recreational vehicles. Many neighbors have built specialized storage areas, including cement pads, covers and electronic operating gates. Having the ability to store these treasures securely behind fencing has community benefits also. The CWCA Covenants requirements are to store RV's, trailers & boats out of site behind a 6' fencing and it also helps to keep crimes of stolen vehicles lower. What



happens when homeowners are not storing things properly? Residents write into CWCAtalk@gmail and ask this very question, numerous times throughout the year, but mostly during the Summer months. "Does the association have any governance?", "Does the association make an effort to connect with the homeowner?", "How long does it take

the association to see a solution?", "Why are there so many homeowners NOT following the Covenants? I am". All great questions worthy of good answers. The CWCA Covenant Control Group (CCG), all volunteer members, monitor the neighborhood monthly. They spend hours monitoring violations, assembling correspondence to be delivered to homeowners and communicating to those who need further clarification. It is never the committee or associations desire to elevate violations to Court status, but is has been done. Court cases have been presented to the Jefferson County Magistrate during night-court proceeding and been ruled in favor of the CWCA Covenants. ### A Moment With the Board

Our August monthly meeting was held at Victory Park, having two picnic tables filled and some lively discussion. The association President spot is OPEN along with (3) Board positions. It was suggested that we drop more information into the newsletter explaining what potential tasks are as volunteers. The group was once again updated on the pool progress, noting that the contractors will be filling the pool to make sure everything is operational before they shut it down for the Winter. The sidewalks were scheduled to be completed before school starts, but weather has caused more delays. The picnic table pavilion has had new concrete poured, along with a new foot path to the bridge. The parking lot is now concrete, trying to mitigate the asphalt issues from the past. Dutch Creek PTSA has asked for the CWCA to join them at the 50th Anniversary carnival, the actual help needed is to be discussed soon. Discussion was held with Kathy Martin, Master Gardener, who has approached CWCA about the renovation of the entrance at Yukon Way/ Coal Mine. Kathy brought us very detailed drawings and plant list to show how the entrance area can be recreated, using much of the existing hard scape material, repositioning plants and adding much needed curb appeal. The association has seen a need to remove plantings that take more volunteer hands than we have. Therefore her recommendations are creating a low maintenance, low water yet high impact entrance design. We will drop sketches into the newsletter soon, along with details on how neighbors can help, either with monetary donations or labor. We are planning to continue our partnership with Dutch Creek PTSA to participate with Trunk or Treat in October. More details to come. 

### Behind The Badge: Help Protect Loved Ones From Scams - May 2023

In the last 60 days, we have taken 24 reports of elder fraud, involving victims age 70 or older. This is a 41% increase from the previous 60 days. Our victims are not numbers, however; they're real people. People like Susan, who was victimized on April 21st, and whose name we have changed to tell her story.

Susan, 76, got a call from a man claiming to work for an Internet provider. He told her that while he was checking her Internet speed, he noticed she had a \$500 credit on her account for services she was entitled to but did not use. He instructed her to get on her computer and when she did, a page was already open that she did not recall opening. The caller told Susan she had accidentally hit a button that selected a refund of \$5,000 instead of \$500. The caller then told Susan he would lose his job if he didn't get the extra \$4,500 back.

The caller instructed Susan to withdraw \$4,500 from her bank and purchase nine \$500 gift cards. He stayed on the phone with Susan while she went to the bank and two separate stores to purchase the gifts cards. During the call, Susan asked him several times if he was scamming her. He said no. Once she had the gift cards, the caller instructed her to tell him the gift card numbers and security codes. Susan did. After the call ended, Susan tried calling his phone number back but the number was disconnected.

Unfortunately Susan was scammed for \$4,500.00. Could the same happen to your parents? Your grandparents? Even you?

Please talk to your loved ones about scams. Think of how many scam calls, emails or texts you get in a week, and you may not even be targeted like older adults are. Elder fraud is one of the more common and frustrating financial crimes. Oftentimes, victims are not able to recover their hard-earned money. And oftentimes, we are not able to identify suspects who hide behind layers of fake identities and cloned phone numbers.

Scams come in many forms, but how we should respond to them is the same:

- Do not answer calls from unknown numbers. If it's important, they'll leave a message.
- Do not provide personal information on the phone or in an email or text message to anyone you do not know. Personal information includes date of birth, social security number, credit card numbers, and bank account information.
- Do not withdraw money, send money, purchase gift cards, or make other financial transactions for someone you do not know.
- If you suspect it's a scam, end all communication hang up the phone or delete the email or text message.
- If you have been scammed or your personal information has been used without your knowledge or permission (for example, a new credit card arrives in your name), report it to local law enforcement immediately (and cancel the card!).
