One submission came from the McKinney's dog, Skipper, "Dutch Creek Barker."

Stephanie won a 6 ft tall pine tree – delivered by a local ReMax realtor.

# Commentary on Adding Wi-Fi Access at Pool House

At the request of several homeowners, we have been investigating adding internet access at the pool house. When the new provider (DirectLink) started running fiber in the subdivision, we thought that would be an option.

However, while DirectLink was digging up our easements, they failed to run an access point to the pool and court area. The good news is that DirectLink not digging around the pool area means they likely didn't destroy anything around the pool house. The bad news is that they now want almost \$4,600 to put in a new DirectLink access point for the pool area. For now, the idea of Wi-Fi at the pool and court area is again on hold.

The Las Vegas address is a lockbox where our payments will be processed automatically for us (no cost to the association for this service through our new bank). The new vendors are intended to reduce fees to the HOA and improve the recordkeeping services we receive. We



will continue to monitor the situation and determine where we can receive the best value for the services provided.

Another question was why the dues always increase annually in recent years. It is my understanding that dues remained level for several years after the first home was continued on page 2

## **Back In Time... DCV History**

4th of July KIDS' BIKE PARADE: Raina Powell recalls that Vicki DeHoff organized this fun family event for at least a couple of years. The decorating of bikes with streamers, flags, etc., took place at home or at the pool parking area and the parade began there. The route was to Weaver Park and back. Did the Kids' Parade take place after the County Parade?

There was a time when Southern Jefferson County had a 4th of July Parade route on Coalmine Ave and S Pierce St. Raina Powell recalls that their kids loved all the candy thrown from the floats! Before Filing II was developed, there was only one way out of Upper Dutch Creek -South of the Creek- of Filing I. Those residents who planned to go anywhere during the parade had to park their cars at the King Soopers or the K-mart lot (now Authentic Life Church.) Leawood Ave. was open to the East so Lower DCV -north of the Creek- of Filing I, residents could leave going East.

Does anyone remember which organization sponsored the big parade?

Dee Pape recalls that there were other residents who took the lead for the Kids' Bike Parade and other social efforts, too. For a time, there was a Couples' Progressive Dinner Club which started at one couple's home for appetizers, moved on for dinner, to another for dessert; and different residents took turns hosting the group.

built in DCV. Then at some point before I moved into the area two things changed. Trash pick-up was added to the HOA services and CPI has been used to increase the base dues amount annually. Increasing the base dues has been necessary since the costs to the HOA are increasing, and we need to plan to have sufficient reserves to cover improvements and replacements for our existing infrastructure to hopefully avoid considering special assessments. Why CPI? Some identifiable measure needed to be chosen to try to avoid future assessment needs and CPI has historically been a common measure of general inflation. The notice of Master HOA dues was mailed around March 1, 2024. If you did not receive a dues notice, please reach out to us at info@dutchcreekhoa.com. We do not enjoy enforcing the rules for late payment of dues, but we attempt to follow the rules exactly to make sure all homeowners are treated equally.

Attending the annual meeting or submitting a proxy is accomplished in the same way. The Master HOA needs your vote or proxy submitted to conduct annual business; therefore, it is greatly appreciated if you can submit a proxy document online if you are not able to attend in person. The annual meeting will include a discussion of the budget, annual elections of board members, and anything else attending homeowners may wish to discuss.
