

# Historically Speaking... Recreation Facility Improvements

Eighteen years ago, the first major round of improvements to our Recreation Facilities was nearly complete. According to the minutes of the Annual Meeting held on May 17, 2007:

- Pool Area Enhancements: A
  new shade structure and sheltered
  picnic table were installed, along
  with black ornamental fencing and
  gate access via proximity cards.
  A new sidewalk was added on the
  east side with an ADA-compliant
  slope, and sod was laid around the
  picnic shelter where the volleyball
  court had been removed.
- Project Leadership: The improvement project was led by Rich Hagan, Facilities Improvement Chairman, with assistance from Tom O'Neill. Committee members included Charlie Swanson and Scott and Juli Thomas.
- HOA Board of Directors at the Time: Lou Day (President), Chris Pillow (Treasurer), Bob Stong, Mark Hannum, Dan Dowell, Peige Visser, and Debbie Swoboda. Eileen Parker served as Secretary.
- Remaining Tasks: The gate, fencing, and landscaping, including the sprinkler system, still needed to be completed prior to Opening Day on Memorial Day weekend.
- Other Improvements: Native grasses were planned for the new open area where the easternmost tennis court had been removed. The extended retaining wall and the wall between the pool and courts were redone later (further research is underway to confirm those dates).
- **Project Cost:** The total cost of the improvements was approximately \$185,000, funded through \$90,000 from reserve funds and a \$90,000 loan. The remaining \$5,000 in costs was covered by reserves generated during 2007–08.

# **Coyote on Dutch Creek Trail** (Encounter from DCV resident)

On a beautiful Sunday afternoon, we were walking along Dutch Creek Trail—three adults, two dogs, and a baby in a stroller—when a coyote suddenly appeared, climbing up from the creek embankment behind us. I expected it to run off, but

instead, it staggered toward us, unsteady on its feet and seemingly unaware of our shouts.

It wasn't aggressive, just... off. It stared blankly, stumbling closer as we slowly backed away. The moment felt more unsettling than threatening.

Eventually, the coyote veered into the brush and disappeared. As soon as it left, we quickly made our way toward the neighborhood and chose an alternate route home. My best guess is that it was sick — possibly suffering from distemper. A quick reminder of how wild the world can be, even so close to home.



After this experience, I felt it was important to share how to respond to coyotes and when to report concerning behavior. Most coyotes avoid humans, but they can become bold if they've been fed, are injured, or are ill.

If you encounter a coyote:

- 1. Stay calm don't run. Running may trigger a chase instinct. Stand your ground and maintain eye contact.
- **2. Make yourself look bigger.** Raise your arms, wave them, or open your jacket. Speak in a loud, firm voice.
- **3. Haze the coyote.** Clap, use a whistle, or throw small objects *near* (not at) the coyote to scare it off.
- **4. Protect your pets.** Keep dogs leashed and pick up small pets immediately. Don't let pets roam unsupervised.
- 5. Back away slowly. Keep facing the covote as you move away.

WHEN TO REPORT A COYOTE: Coyotes that lose their fear of humans can pose a greater risk. Contact animal control if a coyote:

- Follows people or lingers in yards or playgrounds
- Approaches humans without fear, or acts aggressively
- Behaves unusually bold during daylight hours
- Appears disoriented, limping, or visibly injured
- Has patchy fur, scabs, or signs of mange

### SIGNS OF AGGRESSION

- Growling or snarling
- Baring teeth or snapping jaws
- Stiff posture with tail high
- Direct, unbroken eye contact
- Lunging or charging (even if stopping short)
- Ears pinned back
- Raised hackles (hair along the back)

If you see aggressive or sick behavior, please contact local animal control. Coyotes are a natural part of our environment – but safety comes first. Let's stay aware and keep our community safe.

- Parents, chat with your teens! Encourage them to be mindful of their behavior and how it impacts others. A quick conversation about respect and community can go a long way!
- Know the rules. Our pool guidelines are posted at the pool and on our website (dutchcreekhoa.com). They include no smoking/vaping, no alcohol or glass containers.
- Be a community champion. If you notice behavior that doesn't align with our family-friendly vibe, kindly remind others of the rules. If needed, note names or addresses of those exhibiting questionable behavior to report to the HOA so we can address it fairly (e.g., temporarily disabling pool cards for repeat offenders).

### Ideas to Keep a Positive Pool Experience:

- Community vigilance. Let's look out for each other! If you see something, say something—politely first, then report to the HOA if needed.
- Security support. the board may find the need to hire either a pool management company or security to check IDs and ensure everyone follows the rules.
- If reports of questionable behavior continue we may be forced to consider short-term closures for accountability. If an issue arises, we could close the pool for 24 hours and post the reason to encourage responsibility.

# **Short-Term Rental (STR) Regulations Update**

## Case Number: 25-112508AM

Jefferson County Planning & Zoning is proposing a Regulation Amendment to the Short-Term Rental (STR) Regulations. The 4 primary goals of this regulation update are:

- 1. protect long-term housing resources;
- 2. minimize risk of life during emergency evacuations;
- 3. facilitate responsible, safe STR usage to ensure compatibility with surrounding communities; and balance the benefits and burdens of administration
- 4. and enforcement of STR licensing and enforcement.

### **Proposed Draft and Comment Period**

\* A "short-term rental" is currently defined as a single-family detached dwelling (house) or portion thereof that is rented out for accommodations or lodging for a period of fewer than 30 consecutive days. These properties are often rented through websites such as Airbnb and VRBO.
