Spaghetti Squash Recipe

- 1 spaghetti squash
- 1 pack of bacon

Working From Home? Embrace Your Digital Leadership Skills!

I like to think that people who are good leaders will always be good at leading people. That their skills and attributes transcend the era in which they lived and the platform from where they performed.

Leading people in the real world certainly feels as if it should be different than leading people digitally. Years ago, my then-girlfriend explained the classroom tactic of Shock and Awe. "First day, first class" she said, "walk into the classroom, kick the trash can clear across the room, throw a stack of paper into the air, and loudly shout "I'm gonna teach y'all some MATH!!" My guess is that this same technique was probably lost on virtual students. Just as a manager's call to action via zoom might ring hollow for employees who are busy checking email on another screen.

Quality leaders rise above single-dimensional theatrics. They can command the battlefield, a classroom, or even working-remotely. It starts with the understanding that a boss is not synonymous with a leader. Leadership is about the subtle nuances that draw you into some and repel you from others. The French call it "je ne sais quoi," which translates to "really hard to define."

Critically it's the reason we only see a handful of books on leadership that stand the test of time, even though hundreds are published annually on the topic. Leaders place their ego behind their integrity and accountability. They provide a safe path for those who follow. Leaders are above all, team players. We can achieve much more as a team than as individuals. They connect, communicate, and collaborate with those around them.

In the end, the definition of leadership is highly personal, and subject to a myriad of variables. And while there are common traits that separate the good from the bad, it's about being better than you were yesterday. Roosevelt dared us to "do what you can with what you have where you are." What can you do now? Today?



Leawood Metropolitan Recreation And Park District Meeting Minutes of October 11, 2023

The Leawood Metropolitan Recreation and Park District Board meeting was called to order at 6:17 p.m. by President Kyle Sargent. Members present: Judy Anderson/Vice President, Donna Snyder/ Treasurer, and Maggie Tocco. Myra Pasco was unable to attend because of illness. Other District: Debby Baker/Secretary and Dave Padilla/Park Manager

Approval of Agenda – Maggie moved that the proposed agenda be approved. Judy seconded and the proposed agenda was approved without objection.

Approval of Minutes – Judy moved that the minutes of September 13, 2023 meeting, sent to Board Members via email, be approved. Maggie seconded and the minutes were approved without objection.

Public Comments - Kyle received calls regarding weeds in the xeriscape, low hanging and broken tree branches and Yarrow plants (which can be toxic to dogs, cats and horses) in the parks. Board Response: Dave also spoke with the resident. The Board has a contractor who will weed the xeriscape Kyle Responded that the residents should not be weeding the xeriscape. Board Response: Dave will investigate and take action as necessary.

Treasurer's Report – Donna presented the Treasurer's Report. Bills to be paid this month include Weston, Waste Management, Xcel Energy, Denver Water, Doggie Walk Bags, Honey Bucket, Rich Alarcon, Dave's invoice, and reimbursement to petty cash. Judy moved that the Treasurer's Report be received, and bills paid. Maggie seconded and the motion passed unanimously.

Parks Manager Report - All parks were mowed, irrigation inspected, doggie bags checked and replenished as needed. Graffiti continues to be a problem in all the parks.

(A) Leawood Park: The baseball field was repaired, debris removed, and new dirt added.

- (B) Weaver Park: The volleyball court has been removed and new native grass planted. A blanket is protecting the new seed. A branch hanging over a picnic table was trimmed.
- (C) Raccoon Hollar: Urban Drainage removed two large branches. The debris pile has been removed.

OLD BUSINESS

- (A) Update of 2023 projects: Postponed until next meeting due to time constraints.
- (B) Recruitment for the Board, Assistant Park Manager: The Board will work on a job description and a draft contract.
- (C) Record/file storage, retention: Postponed until next meeting due to time constraints.
- (D) Special District Management Companies: Pinnacle Consulting Group submitted a written proposal for the Board to review.

NEW BUSINESS

(A) Discussion of 2024 Budget: Donna presented draft of proposed budget for 2024. For the new Board Members, Kyle walked through the process for determining the budget and explained the different categories and funding sources.

Future Board Meetings: The next Board meeting will be Monday, November 13, 2023, 6:00 p.m. at a location to be determined.

Adjournment: The meeting was adjourned at 8:10 p.m.
